- Phase 1: Student must successfully complete 30 Hours of Classroom instruction with a State of Hawaii Certified Drivers Education Instructor.
- Phase 2: Student must successfully complete 6 Hours of Behind the Wheel (BTW) Instruction with a State of Hawaii Certified Drivers Ed Instructor.
- Phase 3: Student must complete 50 Hours Supervised Driving (40 Daytime driving/10 Night driving): Students Parent/Legal Guardian must Notarize the Affidavit verifying the student has at least 50 hours of driving with a licensed driver 21+ years of age; The completed **Notarized Affidavit** must be submitted to the BTW Instructor in exchange for the BTW Certificate of Completion, Affidavit will be retained by instructor.
